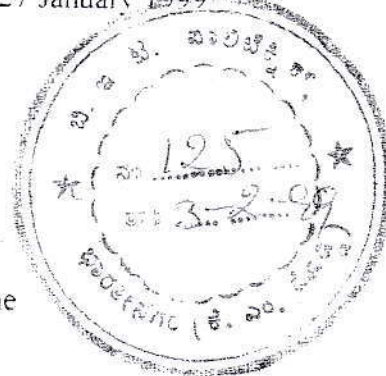

Sir,

Vide the AICTE's approval letters so far issued to your Institutions, it has already been informed that one of the important conditions to be abided by the Institutions and competent authorities implementing the admission procedures is to ensure that no excess admissions are made beyond the intake capacity as approved by AICTE.

In continuation of above, it is to reiterate once again that admissions shall be made only in the approved course(s) and shall limit admission as intake fixed by AICTE and that this shall be strictly followed without deviation what so ever.

Further, in order to update the database being maintained at our office, it is required that the position of admission made in each institution for the current year is furnished for all such approved courses. While such data shall be relevant for the purpose of overall planning it would further be required to estimate the effective utilisation of capacity created as well.

Accordingly, it is informed that all Institutions which have completed the process of admissions, may furnish the details as required to our office at the earliest individually for each of the course approved by AICTE.

To enable to provide the requisite data, a structured format has been enclosed as ANNEXURE - I, which can be used.

In case the Institution is conducting more than one course such as Degree in Engineering, Diploma in Engineering, Degree in Pharmacy, Diploma in Pharmacy, MBA, MCA, BHM, etc., the data should be furnished separately with all supporting documents for each of such programme using separate sheets.


